 - i. Two grants were awarded, one backed out, the remaining one with GPS wrapped up, Charles asked them for an update. They will be presenting and have signed up. CEB III reminded us of our past conversations at this meeting, the need to refocus on how we do the grants, another approach.

5. Regional Reports - Lightning Round

- a. State Coordinator's Reports
 - Arkansas (Brian): finalizing spring Users Forum meeting, anticipating delivery of updated imagery any day now. The State GIS office and USGS have plans to do L1 lidar in half of state during FY 24, then in FY 25 will do western half of the state.
 - ii. Iowa (Patrick): Elevation working group with multiple state agencies and some external, local, and university partners, looking at statewide lidar plan, they have full coverage at this time, getting requests from cities for buy-ups, will be starting challenge process in next 90 days then 6-9 months another rounds of BB grants opening up
 - iii. Illinois (Mark): Mike K for Mark Y county-wide parcel layer being planned, using increased recording charges, looking at finalizing single statewide coordinate system
 - iv. Kansas (Eileen): NRCS and UGSS funded another lidar collection for 15 counties, QL2 replacing some existing, 911 imagery program doing a statewide refresh in February, for 911 they are rolling out RapidDeploy for mapping, using Lightning mobile app for responders, a pilot phase, authoritative data to the responders. Her and Ken invited to the House Water Committee which was a great opportunity. Bob asked about lidar storage and compression. Eileen said lidar



- is zlas stored on-prem, migrating this to Azure for bare earth using COGs, using Azure archive, Patrick said there will be egress fees. At this time, KS is using Azure for web services no download.
- v. Missouri: (Tony/Steve/Tom): Stacey MGISAC is hosting a webinar January 25th at 9:00 AM to learn how one can access the latest 6" leaf off Imagery collected in 2023.
- vi. North Dakota (Bob): Geospatial Summit planning underway: September 25-26, 2024. CDO position has been filled by the interim CDO who I report to. Continuing to have a seat at the "Lighthouse Project" table which is about data integration across agencies, that's a good thing for geospatial. Planning to request a geospatial person in the upcoming budget request. Discussing how to best feed multiple data providers with addresses and road centerlines beginning with Google perhaps. Patrick For addresses when working with broadband and other vendors, he said it's been his experience vendors will pick up the data from the NAD, centerlines maybe the same. Brian C has some experience with RapidDeploy, University of AR recently been using that. RapidDeploy has referenced some ArcGIS Online web services, then share the map layers with the dispatchers. He said Susan may have insight in terms of city and university. For the university, RapidDeploy is using their services (no mobile), the services are coming from Fayetteville and the university. Geocoding from AT&T. Eileen said she and I can chat more, including geocoding services.
